OWNER LISTING AGREEMENT

We would like to help you place your Alaskan Malamute by listing it on our website.

Our goal is to find the correct match for any dog we place; we want the home to be their permanent home so sometimes it may take a little while. We are all very experienced with placing dogs and screening applicants, and while you should still try to solicit homes yourself, you may want to send potential adopters through us as a double check.

We are essentially a referral service. We prescreen any applicants we would send to you, do a homecheck and interview, but it is up to you to talk with them to determine whether this is a home you would like for your dog. We will assist in arranging a mutually satisfactory time for the prospective adopters to meet your dog, and request that you help us to help you by being as flexible as possible.

If we are successful in finding a new family for your dog, WAMAL will collect an adoption fee of \$300.00 from the new family, and have them sign an adoption agreement. If for any reason the adoption does not work out, WAMAL will take the dog back and assume responsibility for finding it a new home.

Please go to pages 2-4 of this form and answer the questions as completely as possible. When it comes to information about your Malamute's temperament and habits, more is better and will be of great interest to potential adopters. Our Listings Coordinator may also call you to discuss your dog and obtain additional information.

Along with this form please send a few favorite photos of your dog to wamal@wamal.com. The photos need to be in JPG format and smaller in size than 1MG. The photos are VERY beneficial, so if you cannot send an any, contact us and we will tell you where to send a hard copy or see if we have someone in the area who can help.

We look forward to working with you to find a new home for your dog.
